About the Survey

This report comes as one of a series of reports launched by the Central Administration of Statistics, covering the twenty-six districts of Lebanon. Producing these reports was a collaborative endeavor between the Central Administration of Statistics (CAS) and the United Nations Development Programme (UNDP).

Official statistics presented in this report are drawn from the findings of the national Labour Force and Households Living Conditions Survey (LFHLCS) that was carried out by CAS between 2018 and 2019 with funding from the Delegation of the European Union to Lebanon and the technical cooperation of the Regional Office for Arab States of the International Labour Organization (ILO)¹.

The 2018-2019 LFHLCS is the first Lebanese survey to produce estimates not only at the national and sub-national governorate (*mouhafaza*) levels, but also at the district (*caza*) level. Lebanon is composed of eight governorates, called mouhafaza, and 26 districts, called caza. Only the governorates of Beirut and Akkar were taken as a whole in the survey sample and were not subdivided into districts.

LFHLCS covered all the population of Lebanon living in primary residential dwellings. It was carried out from April 2018 to March 2019. It did not cover the population living in non-residential units, such as construction and agriculture sites, shops, stores, factories, unfinished buildings, army barracks, refugee camps and adjacent gatherings, and informal settlements.

With an unprecedented complete national sample size of 50,000 households, more than 39,000 responded to the survey, providing a relatively high response rate of 79%.

Through 227 questions organized into 10 modules, the LFHLCS questionnaire gathered extensive data that were used in the production of a broad array of indicators and a cross-sectional analysis regarding:

- The demographic and social characteristics of households and the individuals living in them on a regular basis (more than six months in a year), including information on education, health, social security and others;
- The labour force situation and the economic activity of all active individuals in the household;
- The characteristics of the household and the conditions of the dwellings and the available amenities.

The concepts, definitions and methodologies that were used in the survey, were designed according to the latest international survey statistical standards especially those in line with the 19th ICLS Resolution concerning statistics of work, employment and labour underutilization.²

District Statistics

The district statistics represent an invaluable source of updated information and analysis of the prevailing social and economic conditions in each district. They are made available to the district authorities and leadership - including the Kâim-Makâm (Caza Governor), the District Unions of Municipalities, and a range of other government and non-government district planners, policy makers and users. The district statistics also aim at informing appropriate and evidence-based development policies and programmes at the district level.

This report presents data pertaining to the district of Minieh-Danniyeh, which is situated in the Governorate of North Lebanon.

I. DEMOGRAPHICS

The residents in Minieh-Danniyeh: who and how many are they?


caza of Minnieh-Danniyeh hosted 2.9 per cent of residents of Lebanon, with around 140,800 residents. 50.1 per cent of the residents were females and 49.9 per cent males.

42.9 per cent of the residents in Minieh-Danniyeh were found in the age group 25-64 years. The younger residents of less than 18 years old represented 37.4 per cent of

The survey results show that in 2018–19, the total, whereas those aged between 18 and 24 years old represented 13.2 per cent. The remaining 6.5 per cent were the older residents (65+ years old). (Figure 1)


> In 2018–19, the age dependency ratio³ for Minieh-Danniyeh was 60.9 per cent, exceeding the national level by 7 percentage points (53.9 per cent). It is instructive to note that, compared to the other cazas, this ratio was one of the highest.

Figure 1: Residents in Minieh-Danniyeh 2018-2019




The Survey results showed that males predominated as heads of household. It was estimated that 85.8 per cent of households were headed by a man compared to 81.5 per cent nationally, while 14.2 per cent of households were headed by a woman relatively to 18.5 per cent in Lebanon. (Figure 2)

More than half (55.3 per cent) of all residents aged 15 and above in Minieh-Danniyeh declared that they were "married" in 2018-19, whereas 38.9 per cent stated that they were "never married". The proportion of married women (55.4 per cent) was almost equal to that of married men (55.2 per cent), whereas the share of never married women (34.5 per cent) was lower than for men (43.5 per cent). Interestingly, the share of women who stated they were either widowed, divorced or separated (10.1 per cent) was almost seven times higher than that of men (1.4 per cent). (Figure 3)

WHAT IS THE

The singulate mean age at marriage (SMAM) is the average length of single life expressed in years among those who marry before age 50. It is a synthetic indicator calculated from marital status categories of men and women aged 15 to 54 at the date of the census or the survey.

Among Minieh-Danniyeh residents, the Singulate Mean Age at Marriage (SMAM) was 23.6 years for women and 30.8 years for men, while at the national level, the mean age of marriage was found to be 25.6 and 30.7 for women and men respectively. It is instructive to note that, compared to the national level, data shows an earlier mean age of marriage for women in Minieh-Danniyeh.

³Age dependency ratio is the number of dependents aged 0-14 years and those aged 65+ compared to the total population aged 15-64 years, which is the working age population. It describes the degree to which the economically non-productive population is dependent on the working-age population. The higher the ratio, the greater the economic burden.




II. HOUSING

Where do residents in Minieh-Danniveh live?

The primary residences in Minieh-Danniyeh were mostly apartments (88.7 per cent) whereas only 11.3 per cent were independent houses or villas. It is worth

noting that the percentage of apartments at the caza level exceeded slightly that at the national level (85.5 per cent). (Figure 4)

Figure 4: Distribution of primary residences by type of dwelling



58 per cent of the primary residences in of the dwellings compared to 15.4 per cent Minieh-Danniyeh were 130 square meters and more compared to 45.9 per cent at the national level. Small residences of less than 80 m² were the least common – 5.3 per cent nationally. (Figure 5)

Figure 5: Primary residences by area of residence (%)




How many rooms does a household have?

The primary residences of 4 rooms and (64.7 per cent), followed by 27 per cent of dwellings composed of 3 rooms. Nationally,

57.8 per cent of the primary residences had more were the most common in the district 4 rooms and over and 25.1 per cent had 3 rooms. (Figure 6)

Figure 6: Primary residences by number of rooms (%)




Persons per room

The number of individuals per room is an indicator that provides a measure of residential crowding and occupancy.


Figure 7: Persons per room (%)

In Minieh-Danniyeh, the vast majority of households had a density of less than two individuals per room, with approximately 50.5 per cent of households between one and two individuals per room and around one third (30.4 per cent) less than one individual per room. Compared to the

the distribution of national level, households was higher for a density between one and two individuals per room whereas it was lower for a density of less than one individual per room. As for the residences that were found to be more crowded (more than two persons per room), they represented 19.1 per cent of the households, a proportion greater than the national level. (Figure 7)

Are the primary residences old or new?

38.6 per cent of the dwellings in Minieh-Danniyeh were constructed between 25 and 49 years ago, a proportion greater than that observed all over Lebanon (34.4 per cent). On the other side, 33.8 per cent of primary residences were constructed less than 25 years ago at both the national and district levels. (Figure 8)

Connectivity to infrastructure and utilities


Figure 9: Facilities of main source of drinking water at the dwelling (%)

Non-piped water supply (49.2 per cent) was the main source of drinking water in Minieh-Danniyeh, yet considerably less prevalent at the district level than the national level (76.9 per cent). For 46.4 per cent of households,

drinking water was in the form of a supply piped directly to the residence, whereas 4.3 per cent of dwellings had no drinking water facility whatsoever. (Figure 9)

Connection to the public electricity network At the national level, similar results were was the most common in the caza (99.1 per cent), whereas 72.1 per cent of households were subscribed to a private electricity source or had their own private generator.

observed for the connection to the public electricity; however, subscription to a private electricity was less prevalent in Minieh-Danniyeh (84 per cent in Lebanon). (Figure 10)

Cost associated with residence

The average yearly expenditure on services for main dwellings in Minieh-Danniyeh was estimated at approximately 2,694 thousand LBP, compared to 3,308 thousand LBP nationally. At the district level, average spending was mainly on generators (660 thousand LBP) followed by electricity (574 thousand LBP); whereas the lowest average yearly expenses were on satellite/dish (130 thousand LBP). These expenses were lower compared to the ones observed at the national level. The median annual expenses in the district were 2,920 thousand LBP, which was slightly lower than that observed in Lebanon as a whole (2,940 thousand LBP). (Table 1)



Home appliances and means of transportation

Almost all households had a water heating system and a refrigerator in Minieh-Danniyeh. Dishwashers were the least common in the district (only 1 per cent of households) with a lower proportion relatively to the national level (6 per cent). It is also interesting to note that the proportion of the primary residences who

had a satellite dish in the caza (93 per cent) exceeded considerably that of the country level (62 per cent). However, home appliances such as television (flat screen), washing machine, microwave, internet and laptop were significantly less prevalent in the caza. (Figure 11)


Access to basic services

The vast majority of primary residences had access to at least one grocery store (93 per cent), public transports (82 per cent) and a bakery (80 per cent) within a 10-minute walk from home. Hospitals (10 per cent) and bank branches (5 per cent) were the least common services in Minieh-Danniyeh. Only 43 per cent lived within reach of a pharmacy compared to 69 per cent at the national level and around a third (31 per

cent) were close to a private clinic, compared to 53 per cent nationally.

It is also worth noting that compared to the national level, access to a secondary school was 14 percentage points less (30 per cent in Minieh-Danniyeh and 44 per cent in Lebanon) and the widespread of bank branches was seven times lower (5 per cent in Minieh-Danniyeh and 35 per cent in Lebanon). III. EDUCATION

Gross Enrolment Ratio versus Net Enrolment Rate

Enrolment Rate (NER) decreased with level. In Minieh-Danniyeh, the GER at the elementary level was 109.6 per cent while it was 82.4 per cent at the secondary level. The NER at the elementary level was 93.1 per cent, but decreased to 46.4 per cent at

Both Gross Enrolment Ratio (GER) and Net the secondary level. Interestingly, the gross enrolment ratio was at all levels greater in Minieh-Danniyeh than the national level. However, the net enrolment rate was lower in the caza, except for the elementary level. (Table 2)

WHAT ARE THE **GER AND NER?**

The Gross Enrolment Ratio (GER) is defined as the number of students enrolled in a given level of education, regardless of age, expressed as a percentage of the official school-age population corresponding to the same level of education. A high GER generally indicates a high degree of participation, whether the pupils belong to the official age group or not. A GER value approaching or exceeding 100% indicates that a country is, in principle, able to accommodate all of its school-age population.

The Net Enrolment Rate (NER) is defined as the total number of students in the theoretical age group for a given level of education enrolled in that level, expressed as a percentage of the total population in that age group. A high NER denotes a high degree of coverage for the official school-age population. The theoretical maximum value is 100%.

Schooling in Minieh-Danniyeh





Figure 13: Distribution of students by type

In Minieh-Danniyeh, students aged 3-24 years were more likely to enrol in public educational institutions (63.6 per cent), rather than private institutions (27.6 per cent). At the national level, the enrolment in public institutions was remarkably lower (46.5 per cent); however, the enrolment in private institutions was considerably higher (47.8 per cent). (Figure 13)

The "primary and below" level⁴ was the highest educational attainment in the caza (44.3 per cent), with a higher proportion for males (48.9 per cent) than females (39.7 per cent). Although illiterate residents aged 3 years and above were twice as high among females (8.7 per cent) as among males (4.4 per cent) at the national level, gender

discrepancies were more observed at the caza level (4.4 per cent for men and 9.7 per cent for women). This result may be explained by the fact that the proportion of elderly women aged 65+ years is greater than that of men. Furthermore, the survey results show that the illiteracy rate among the elderly is greater. (Figure 14)

Figure 14: Residents (aged 3+) by level of education attained and sex (%)



residents aged 10 years and above increased with age. 46.1 per cent of residents aged 65 years old and above were illiterate. In contrast, 1.2 per cent of those aged between 10 and 17 years old were illiterate. It is worth noting that women

The survey shows that the illiteracy rate for aged 25 + years old were more likely to be illiterate than men; yet, gender discrepancies were mostly noticed for illiterate residents aged 65 years and more, with a notable gender gap reaching 35 percentage points (62.4 per cent for women and 27.4 per cent for men). (Figure 15a)


Figure 15a: Illiteracy rate by age group and sex (aged 10 years +)



When compared with the national level, illiteracy rate in Minieh-Danniyeh was reported to be slightly above the national level (8.3 per cent in comparison with 7.4 per cent at the country level). This rate was found to be at least twice higher for women

(11.4 per cent) than for men (5.2 per cent) in the district, whereas in Lebanon, the proportion of illiterate women (9.7 per cent) was almost twice as high as that of men (4.9 per cent). (Figure 15b)


IV. SOCIAL AND ECONOMIC BACKGROUND

How much do households earn in total?

Minieh-Danniyeh recorded one of the highest shares of households with income less than 650 thousand LBP in the month preceding the Survey (31.8 per cent). That was followed by almost an equal distribution of households at the caza level earning an income ranging between 650 and 1,200 thousand LBP (27.5 per cent) and between 1,200 and 2,400 thousand LBP (27.9 per cent). In contrast, households in Minieh-Danniyeh were less likely to earn a

total income of more than 2.400 thousand LBP compared to the other income categories: 10.6 per cent earned between [2400-5000] thousand LBP whereas only 2.1 per cent had an income greater than 5 million LBP. Compared to the national level, it is interesting to note that households in Minieh-Danniyeh were more likely to have earnings below 1,200 thousand LBP, whereas they were less likely to earn more than this amount. Figure 16: Household income range from all sources in the month preceding the Survey in thousand LBP (%)




... and how do they perceive their wealth status?

Households classified their wealth status from their own subjective point of view. Minieh-Danniyeh hosted the highest share nationally of "poor or very poor" households from their own point of view (48.6 per cent). On the other side, 47.8 per cent of the households classified themselves as "average or average to poor" and only 3.6

per cent declared they are "wealthy or financially well-off". Nationally, although the proportion of households who classified themselves as "average or average to poor" was higher in Lebanon (67.5 per cent), the proportion of those who considered themselves "poor or very poor" was lower (26.3 per cent). Figure 17: Self classification of wealth of households




Health Coverage⁵


Figure 18: Health coverage by sex (%)

Minieh-Danniyeh not only had the lowest was found for women (37.6 per cent) than health coverage within the governorate of North Lebanon, but also across Lebanon, with only 37.3 per cent of its residents covered by at least one type of health insurance. A slightly higher health coverage

for men (36.9 per cent). At the national level, the results show a relatively higher health coverage for both women (56.2 per cent) and men (54.9 per cent). (Figure 18)


Figure 19: Residents (aged 15 years +) by employment status and health insurance coverage (%)

In Minieh-Danniyeh, 36.2 per cent of the outside the labour force who were covered in Minieh-Danniyeh (36 per cent, 29.1 per health coverage, whereas nationally, the cent and 37.5 per cent respectively) were all less than those observed at the national level. It is worth noting that unemployed residents were the least covered in the district. (Figure 19)

The main source of health coverage in Minieh-Danniyeh was the National Social Security Fund (NSSF)⁶, which covered 47.9 per cent of the insured population, followed by the Lebanese Army and the Internal Security Forces (24.4 per cent). The

coverage of the Public Servants Cooperation was almost equal in Minieh-Danniyeh and in Lebanon, whereas private insurance was five times less prevalent (2.1 per cent in Minieh-Danniyeh compared to 10.5 per cent in Lebanon). (Figure 20)




V. LABOUR FORCE and EMPLOYMENT

Labour market structure

Among the estimated 96,600 individuals were in the labour force, either employed aged 15 years old and above living in primary residential dwellings in Minieh-Danniyeh in 2018–19, about 46,800 people the labour force.



Who is Employed, Searching for a job or Inactive - From a Gender Point of View

Total labour force participation rate⁷ in Minieh-Danniyeh was 48.4 per cent, which was nearly the same as the national rate of 48.8 per cent. Gender disparity was high and more accentuated than the national level. Men's participation rates (74.8 percent in Minieh-Danniyeh and 70.4 per cent in

Lebanon) were higher compared to women's (22.2 per cent in Minieh-Danniyeh and 29.3 per cent in Lebanon) at both the district and national levels, with a notable gender gap⁸ reaching a difference of 52.6 percentage points and 41.1 percentage points respectively. (Figure 21)

The share of the adult labour force (be they the youth and marked 52.6 per cent compared to 37.8 per cent in Minieh-

Danniyeh, and 51.7 per cent compared to unemployed or in work) exceeded that of 39.2 per cent at the national level. (Figure 22)

Figure 22: Labour force participation rate among youth and adults (%)




The employment-to-population ratio in Minieh-Danniyeh (39.8 per cent) was lower than that of the country (43.3 per cent). There were some notable gender disparities in the employment-to-population ratio at both the district and country levels. The employment-to-population ratio reached 15.2 per cent for women and 64.7 per cent

for men aged 15 years and above in Minieh-Danniyeh, marking a gender gap of 49.5 percentage-point difference. In Lebanon, 25.1 per cent of women and 63.4 per cent of men were employed with a gender gap of 38.3 percentage-point difference.

Figure 23: Employment-to-population ratio (%)




The comparison of the results by broad age groups shows that the youth employmentto-population ratio in Minieh-Danniyeh (24.2 per cent) was considerably lower than that of the adults (45.9 per cent). When compared with the national level, these

ratios were lower for the youth, but very close for the adults. However, the gap between the two age groups was more significant at the caza level (21.7 percentage-point difference relative to 17.2 percentage points in Lebanon). (Figure 24)


Figure 25: Unemployment rate by sex (%)

Among all the districts in Lebanon, Minieh-Danniyeh had the highest rate of unemployment⁹ (17.8 per cent) and exceeded that of Lebanon (11.4 per cent). Differences at the country level were observed between men (10 per cent) and women (14.3 per cent), yet the gap was higher in Minieh-Danniyeh where the

unemployment rate was 13.6 per cent for men and 31.7 per cent for women. In other words, the gender gap in the unemployment rate was more significant in Miniehpercentage-point Danniyeh (18.1)difference) than in Lebanon as a whole (4.3 percentage-point difference). (Figure 25)

Unemployment was less prevalent among a whole. The gap between the youth and adults than among youth at both the district and country levels, with a rate reaching 12.7 per cent and 36 per cent respectively in Minieh-Danniyeh, compared to 8.6 per cent whole. (Figure 26) and 23.3 per cent respectively in Lebanon as

the adults' unemployment rate reached 23.3 percentage points in Minieh-Danniyeh and 14.7 percentage points in Lebanon as a

Figure 26: Unemployment rate among youth and adults (%)



The inactivity rate, which represents the proportion of the persons considered inactive- neither working nor looking for any *job*- in the total population aged 15 years and above in Minieh-Danniyeh (51.6 per cent) was almost equal to that of Lebanon

(51.2 per cent). 77.8 per cent of women and 25.2 per cent of men were inactive at the caza level, compared to 70.7 per cent of women and 29.6 per cent of men at the national level. (Figure 27)

Figure 27: Inactivity rate of residents aged 15 years + (%)




Where do they work?

The Services sector was the largest employment sector for women and men, with respectively 77.2 per cent and 53.5 per cent in Minieh-Danniyeh, compared to 91.7 per cent and 68.8 per cent in Lebanon. In this sector, women surpassed men by 23.7 percentage points at the caza level. It was particularly noticeable that 35.3 per cent of working men and 7.5 per cent of working women were employed in industry in

Minieh-Danniyeh, compared to 26.6 per cent of working men and 6.7 per cent of working women in the whole of Lebanon. Compared with the national level, employment in agriculture in Minieh-Danniyeh was greater by 6.8 percentage points for working men and by 13.8 percentage points for working women. (Figure 28)

Figure 28: Economic activity sector by sex (%)




... and how many hours per week

Men in employment were reported to be working longer paid hours than women. The average number of actual weekly paid hours was 45.7 for men and 33.4 for women. Furthermore, the actual number of hours of work was slightly below the usual number of

hours for both sexes, due to temporary absences such as vacation, annual leave, etc. In Lebanon as a whole, the actual number of hours of work was 50 per cent for men and 39.1 per cent for women. (Figure 29)

What type of jobs do they hold and where?

According to the ILO, the concept of "informal employment" refers to jobs that do not provide employees with legal or social protection, thus exposing them to greater economic risks than other employed people. As for concept of the "informal sector", it is a subset of unincorporated enterprises not constituted as separate legal entities independent of their owners.

The results show that the majority of the employed population (71.7 per cent) in

Minieh-Danniyeh held informal jobs at their main occupation, among which 51.7 per cent were working in the informal sector and in informal jobs. It is instructive to note that the latter proportion was higher compared to the national level (35.1 per cent). The proportion of employed individuals holding an informal job in a formal sector (20 per cent) was almost equal to that observed in Lebanon (19.8 per cent). (Table 3)



Women's share in employment was low, yet more prevalent for paid employment than "employer/own-account worker". The majority of employers or own-account workers in Minieh-Danniyeh were men (85.1 per cent), a proportion that was

almost equal to the national level (85.6 per cent). Men's share in paid employment was higher in Minieh-Danniyeh compared to the national level (78.8 per cent and 63.5 per cent respectively). (Figure 30)

Figure 30: Employed (15 years and above) by employment status and sex (%)




How many jobs are "vulnerable"?

In Minieh-Danniyeh, vulnerable employment was reported to be considerably higher than that observed at the country level (31.4 per cent and 20.1 per cent respectively).). It is worth noting that vulnerable employment was

substantially higher for both women and men in Minieh-Danniyeh compared to the whole of Lebanon. Moreover, it was more prevalent among men (32.1 per cent) than among women (28.6 per cent). (Figure 31)

Youth in Employment versus Youth Not in Education, Employment or Training (NEET)


Youth NEET rate - Youth not in education, employment or training rate - (24.4 per cent) in Minieh-Danniyeh was almost equal to the youth employment-to-population ratio (24.2 per cent), whereas at the country

level, Youth NEET rate was 21.8 per cent and the youth employment-to-population ratio was 30 per cent. Moreover, women's NEET rate (31.5 per cent) was remarkably higher than that of men (18 per cent). (Figure 32)

DID YOU KNOW?

According to the International Labour Organization (ILO) definition, "Vulnerable Employment" is the sum of own-account workers and contributing family workers in total employment. This category of workers has a lower likelihood of having formal work arrangements and is therefore more likely to lack elements associated with adequate social security and a voice at work.
