


TRADE EXCHANGE BETWEEN LEBANON AND INDIA

The Lebanese trade balance with India has been negative (deficit) since 1994. The trade deficit reached a record high value of 382.4 million USD in 2014.

Imports from India accounted for 1.3 % of total Lebanese imports in 2020. On the other hand, Lebanese exports to India only formed 0.3 % of total Lebanese exports in 2020.

During the last ten years, Lebanese exports to India decreased from \$23.1 million in 2010 to \$11.9 million in 2020, a decrease of 48.5 percent. These exports reached a record value of \$25.5 million in 2013.

Lebanon's exports to India in 2019 were not diversified, and 75 percent of these exports were limited to raw materials of iron, steel and copper.

Lebanese imports also decreased of 50.5 percent from \$296.4 million in 2010 to \$146.8 million in 2020. These imports reached a record value of \$407.8 million in 2013 as well.

As for Lebanon's imports from India, they were of limited variety, and imports of 5 products accounted for about 40 percent of Lebanon's imports from India.



In the context of activating economic relations between Lebanon and India, and increasing trade exchange between them, the Chamber of Commerce, Industry and Agriculture in Beirut and Mount Lebanon signed two cooperation agreements on October 14, 2011, the first with the Federation of Indian Chambers, and the second with the Federation of Indian Industries.

The products with greatest export potential from Lebanon to India

The products with greatest export potential from Lebanon to India are Phosphoric acid; poly-phosphoric acids, Diamonds, worked and Unwrought lead, refined lead. Lebanon has the highest supply capacity in Nuts & other seeds, prepared or preserved. Diamonds worked on is the product that faces the strongest demand potential in India.



The value of Lebanese exports to the world in 2019 amounted to about 3.7 billion dollars, of which 11.8 billion dollars were to India amounting to 0.3 percent. While the value of India's imports from the world amounted to 478.9 billion dollars, including 11.8 billion dollars from Lebanon amounting to nearly zero percent.

India imported from Lebanon 3 percent of the value of its iron and steel exports, 3 percent of the value of its exports of copper and its products, 2 percent of the value of its exports of lead and its products, and 1 percent of the value of its exports of pharmaceutical products.
